- Applications with negligible drift have no distance requirement, such as applications using a hand sprayer or within a greenhouse.

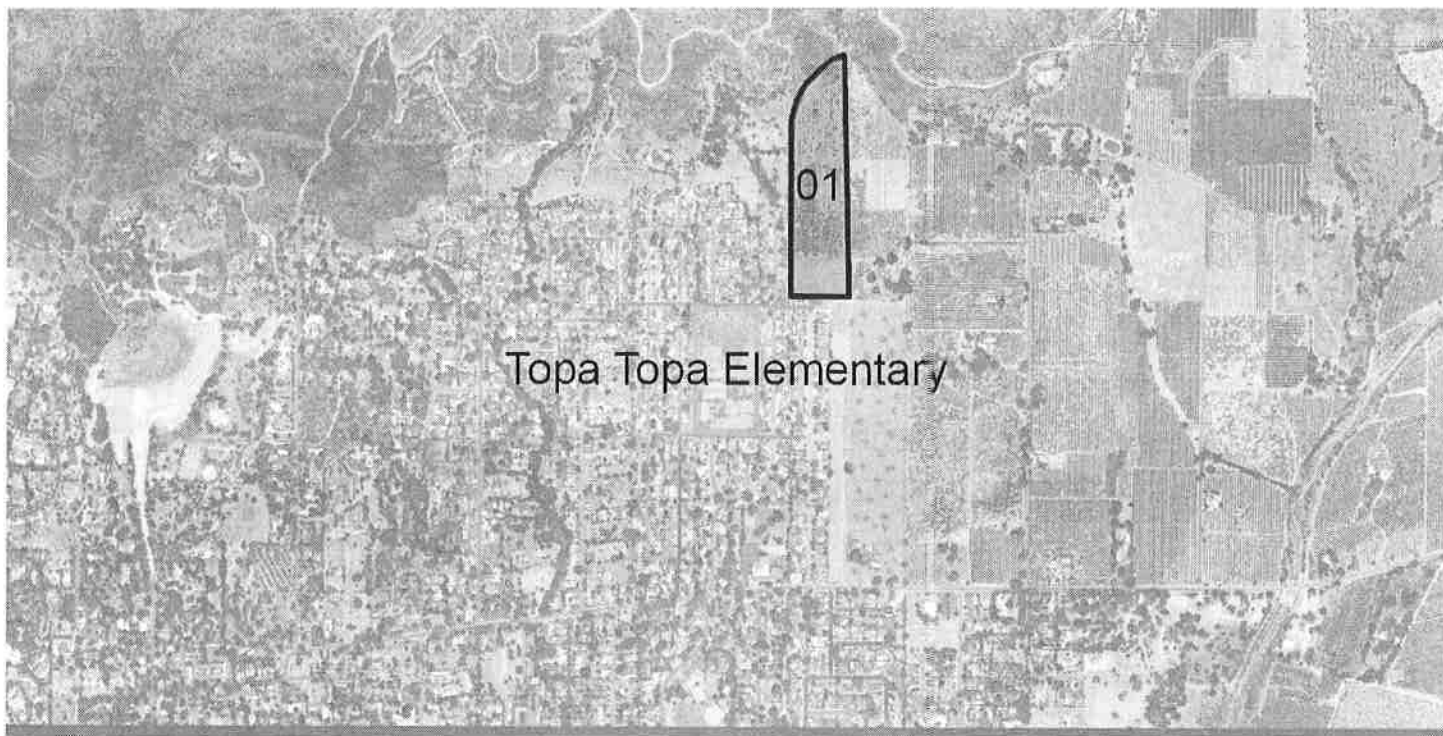

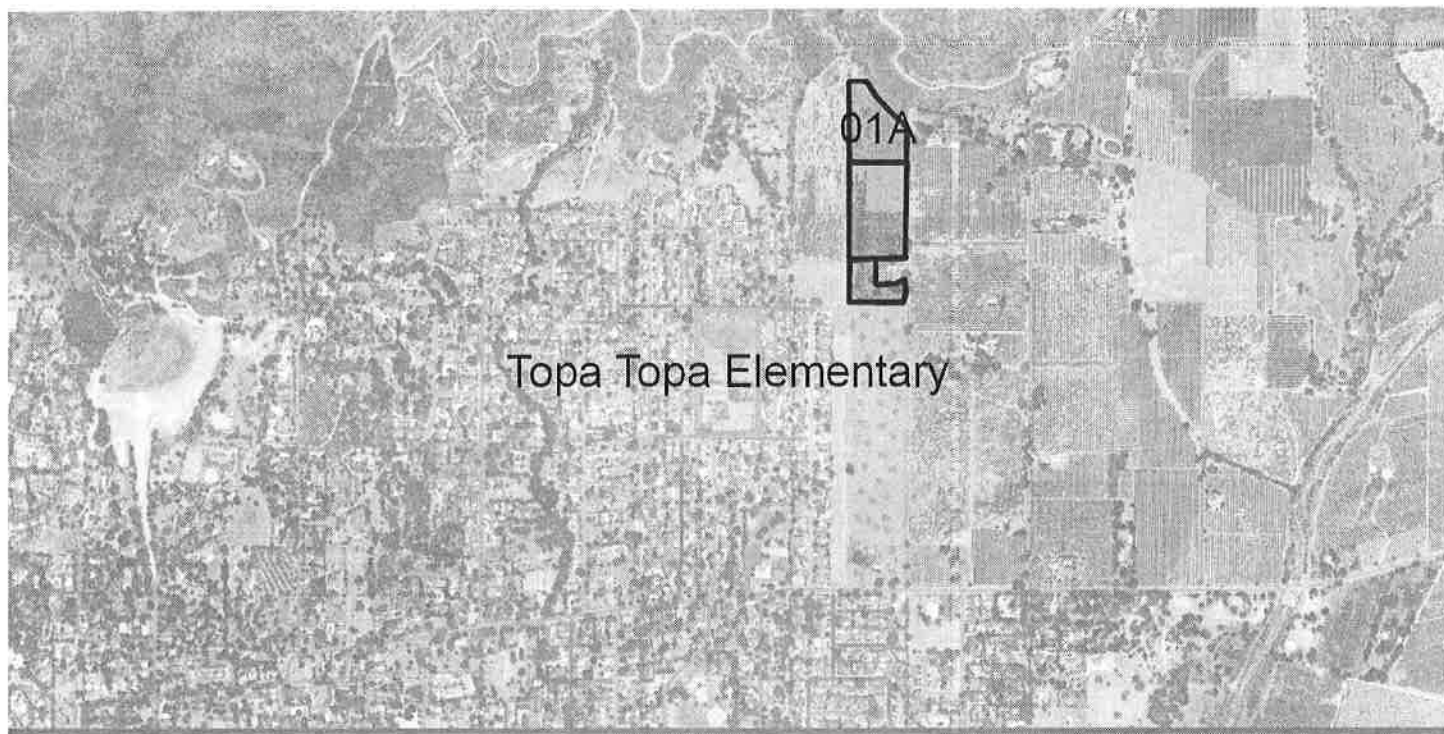

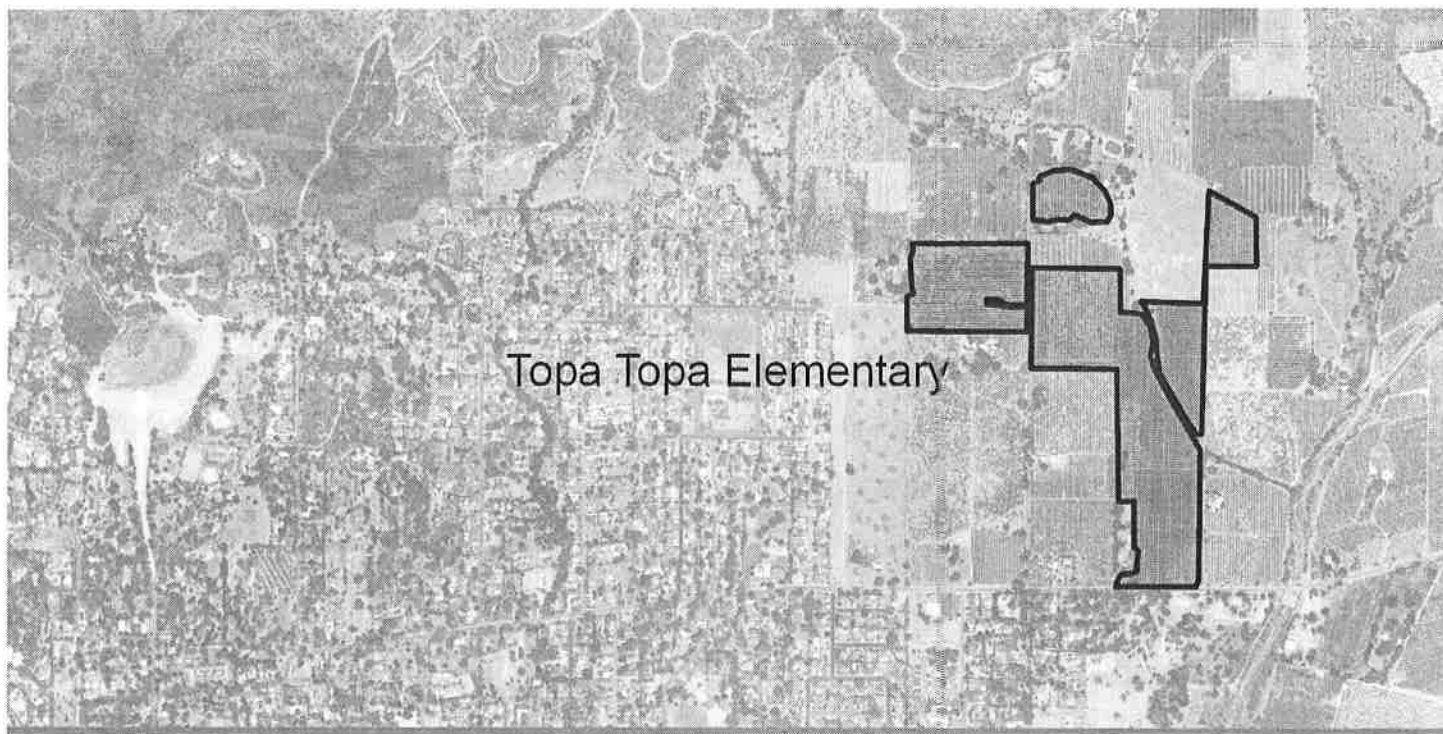
